

# A CONSERVATION BURIAL ASSESSMENT TOOL

These are questions we have been asked—and helped answer—for our land trust clients while developing conservation burial projects with them. They are relevant for land trust staff, conservation burial champions, or in preparing for a presentation to an executive director, Board member or community partner.

#### **CONSERVATION**

- 1. Does a conservation burial project fit with your organization's mission?
- 2. What are your organization's goals for a conservation burial project?
- 3. Would a conservation burial project contain conservation values you seek to advance?
- 4. What resources does your organization have available for a conservation burial project? (Consider resources such as: land, expertise, financials, willing community)
- 5. What barriers do you foresee in considering a conservation burial project?
- 6. Given your organization's objectives and obligations would a conservation burial project be a priority?
- 7. Can a conservation burial project advance your conservation or organizational strategies?
- 8. Does your organization have target conservation priorities or an existing conservation property that a conservation burial could benefit?

#### **COMMUNITY**

- 1. Are there any green, natural or conservation burial grounds within your service area?
- 2. Are there any natural burial grounds within 50 miles of your service area?
- 3. Has your organization been asked about green burial by its members/community members?
- 4. Have you identified community goals that could be supported by a conservation burial project?
- 5. Can a conservation burial project further connect your organization to your community?
- 6. Do you have business, religious or organizational partnerships that would benefit the project?
- 7. Who in your community would be supporters and advocates for a conservation burial project?
- 8. Are those partners ready?

### **STRUCTURE**

- 1. Is your organization willing to participate in a conservation burial project?
- 2. Will your organization lead or partner on the project?
- 3. What is your organization's resource capacity for developing a conservation burial project?
- 4. Will you need to give up an organizational priority in order to participate in a project?
- 5. Does your organization have the time to develop a conservation burial project?
- 6. Have you researched your state's cemetery laws, local regulations, zoning?
- 7. What is the market for potential clients for the conservation burial ground
- 8. Does your organization have a conservation burial champion? Is it you??
